CHAPTER I

INTRODUCTION

1.1. Background of the Problem

According to Hatch (1992) speech act is the key concept in the field of pragmatics, the study of speaker's intentions and what the speakers mean when they use the particular linguistics in context. According to Thomas

(1995) people do not use language just to state things but to do things, and to perform actions. People can also perform anther kind of act simply by using language; these are called speech acts.

According to Mey (2001) speech acts are verbal actions happening in the world. Uttering a speech act, I do something with my words : I perform an *activity* that (at least intentionally) brings about a change in the existing state of affairs (hence the label, ' performative utterances', that originally was attached to speech acs). The original distinction between the different aspect of speech acting is due to Austin (1962). First, we have the *locutionary* aspect: this is simply the activity we engange in when we say something, e.g.:

(1) It's cold in here.

Under normal circumstances, the statement (not a wish, promise, threat, judgment or what have you). This paticular aspect of the speech act is its *illocutionary* 'force' or 'point': for many pragmaticians, this illocutionary force is intimately related to the very form the utterance may have: stating, wishing, promising etc. I will come back to this below

Speech act in linguistic is something expressed by an individual that not only presents information, but performs an action as well. Speech acts are comonplace in everyday interactions and are important for communication.

Speech act can be found in many kinds of communication. One of them is in social media such as twitter. Twitter is a free social media networking microblogging service that allows registered members to broadcast short posts called tweets. Twitter members can broadcast tweets and follow other user's tweet by using multiple platforms and devices. Tweets and replies to tweets can be sent by cell phone text message, desktop client or by posting at the Twitter.com website.

Tweets, wich may include hyperlinks, are limited to 140 characters, due to the constraints of Twitter's Short Message Service (SMS) delivery system. Because tweets can be delivered to followers in real time, they might seem like instant message. But unlike that disappear when the user closes the application, tweets are also posted on the Twitter website. They are permanent, they are searchable and they are public. Anyone can search tweets twitter, whether they are a member or not.

Justin Bieber is one of famous people and Canadian singer-songwriter. Justin Bieber has many achievements so many people like him, therefore the author chose to analyze Twitter from Justin Bieber. The writer find many types and social function in Justin Bieber tweets.
