# **5.1 Conclusion**

This is the last chapter with the results of the discussion and analysis in previous chapter used the positive politeness strategy based on Brown and Levinson in the first presidential debate between Donald trump and Joe Biden. The writer found 8 strategies from 15 positive politeness strategies, and found seventeen dialogue from that eight strategies found. they are 1) Exaggerate (interest, approval, sympathy with H), there are 2 dialogue found in this strategy, 2) Intensify interest to the hearer, there are 1 dialogue found in this strategy, 3) Seek agreement, there are 2 dialogue found in this strategy, 4) Avoid disagreement, only 1 dialogue found in this strategy, 5) Offer, promise, 2 dialogue found in this strategy, 6) Be optimistic, 2 dialogue found in this strategy, 7) Include both the speaker and the hearer in the activity, 3 dialogue found in this strategy, 8) Give(or ask for) reason, 4 dialogue found in this strategy.

Based on the analysis of the factor influencing used the positive politeness strategies in the first presidential debate between Donald trump and Joe Biden, that found there are two factors, namely payoff and relevant circumstance (social distance, relative power, and imposition). the first is payoff, by applying positive politeness strategies the speaker can get some advantages and fulfilled the hearer wants. the speaker can minimize the FTA by convincing the hearer that the speaker considers himself to be the same kind. Another possible payoff is that the speaker can avoid or minimize the debt implication of FTA such as request and offer. Thus, this factor found in 6 data.

The second factor is relative circumstances (relative power, social distances, absolute ranking of imposition) In this research, the writer found eleven dialogues that are influenced by relevant circumstances

# **5.2 Suggestion**

The writer believes that this research is interest to analyze. In this research, the writer just analyzed and focused on one types of politeness strategies, is positive politeness strategies in the first presidential debate between Donald trump and Joe Biden.
