ABSTRACT

The purpose of this research was to find out difficulties made by the fourth year students to construct complex sentences by using adverb clauses at English Department of FKIP Bung Hatta University. Descriptive method was used as the design of this research. The number of population members was 53 students. The researcher used convenience sampling to select the sample and the total number of sample members was 38 students.

The instrument used to get the data was writing sentence test. The students were asked to write 20 complex sentences using adverb clauses: 10 complex sentences containing adverb clause of time and 10 complex sentences containing adverb clause of cause and effect. It was found that the reliability index of the test was very high (0.96). It means that the test was reliable. Then, the test was valid in terms of content validity.

Generally, the results of data analysis showed that 23.24% of difficulties related to writing the independent clause, 29.73% of difficulties related to writing the dependent clause, 17.73% of difficulties related to expressing the relationship between independent clause and dependent clause, and 29.28% of difficulties related to applyning mechanics. Specifically, the result of data analysis showed that 22.33% of difficulties related to writing the independent clause in adverb clause of time, 30.91% of difficulties related to writing the dependent clause in adverb clause of time, 18.78% of difficulties related to expressing the relationship between independent clause and dependent clause in adverb clause of time, 27.95% of difficulties related toapplying mechanics in adverb clause of time. Moreover, 24.17% of difficulties related to writing the independent clause in adverb clause of cause and effect, 28.52% of difficulties related to writing the dependent clause in adverb clause of cause and effect, 16.67% of difficulties related to expressing the relationship between independent clause and dependent clause in adverb clause of cause and effect, and 30.63% of difficulties related to applying mechanics in adverb clause of cause and effect.

Referring to the result of this research, the researcher concluded that the highest percentage of difficulties related to writing the dependent clause in adverb clause of time and applying mechanics in adverb clause of cause and effect. Therefore, the lecturers should give more explanation about the two aspects. The students should pay more attention when the lecturer explains about the lesson and do more exercises.

CHAPTER I

INTRODUCTION

In this chapter, the researcher discusses the background of the problem, the identification of the problem, the limitation of the problem, the formulation of the problem, the research questions, the purposes of the study, the significance of the study, and the definition of key terms.

1.1 The Background of the Problem

Language is a very important tool of communication to communicate between two or more people in carrying out their daily activities and has main role to make people have mutual understanding. English as the first foreign language in Indonesia is important for developing and applying science and technology, as well as for increasing international relationship and cooperation.

English is very important and useful for everyone in the world to make communication easier. English is one of important subjects to achieve the goal of national education. In Indonesia, English is still a foreign language and it is not often used in Indonesian daily communication. English language teaching has a special position in schools. Especially in a big city or in a town, many people learn English. English becomes a compulsory subject in junior high school.

The English language has two parts, they are language skills and language components. Language skills include listening, speaking, reading and writing. Language components include pronunciation, vocabulary, and grammar.

In order to learn English well, both the language skills and language components are interrelated each other. Structure is one of the important subjects that must be studied by students. By learning structure , it is easier for the students to construct good sentences and develop the four language skills above.

Structure is also studied at the fourth year students at English Department of FKIP Bung Hatta University. The Structure covers Basic Grammar, Intermediate Grammar, and Advanced Grammar. The purpose is the students should be able to use correct structure in writing and speaking. The researcher focused on Advanced Grammar because they had studied it. In Advanced Grammar, the students studied about complex sentences.

Based on researcher's informal interview with the fourth year students at English Department of Bung Hatta University about adverb clause, they were still confused about constructing complex sentence using adverb clause. The researcher gave some questions about complex sentence. Most of them still had errors in constructing complex sentence using adverb clause. When they wrote sentences using adverb clauses, it was difficult for them to understand the form or pattern, to remember the form, and to use appropriate adverb clause of time and adverb clause of cause and effect. The researcher chose adverb clause of time and adverb clause of cause and effect because some students had errors in writing complex sentences using adverb clause of time and cause and effect.

The researcher concluded that the students had trouble in constructing complex sentences by using adverb clauses although they had learnt about adverb clauses in Advanced Grammar subject. It made the researcher wants to know further the students' difficulties to construct complex sentences by using adverb clauses. And the researcher chose adverb clauses as the topic in her study because it was familiar for the fourth year students at English Department of Bung Hatta University.

The followings are some examples of students' difficulty to write complex sentence using adverb clause:

1. When Sari at home the father read a newspaper. (error)

a. *When Sari was at home*, the father read a newspaper. (correct)b. The father read a newspaper *when Sari was at home*. (correct)

- 2. Rahmi go to the market, because she was hungry. (error)
 - a. Rahmi went to the market *because she was hungry*. (correct)
 - b. Because she was hungry, Rahmi went to the market. (correct)

The sentences become incorrect ones because the students had low ability in constructing sentences using adverb clause. Adverb clauses are dependent clauses. They couldn't stand alone as a sentence in written English; it must be combined with an independent clause to form a complex sentence (Oshima and Hogue, 1998:195).

Based on the problem above, the researcher wanted to describe the fourth year students' difficulties to construct complex sentences by using adverb clause of time and cause and effect.

1.2 The Identification of the Problem

A complex sentence contains one independent clause and one (or more) dependent clause(s). In a complex sentence, one idea is generally more important than the other one. The more important idea is placed in the independent clause and the less important idea is placed in the dependent clause (Oshima and Hogue, 1998:160).

There are three kinds of dependent clauses: adjective clause, noun clause and adverb clause. A dependent adjective clause (relative clause) begins with a relative pronoun such as *who, whom, which, whose, or that,* or with a relative adverb such as *where* or *when.* A dependent noun clause functions as a noun and begins with a *wh-question word, that, whether,* or sometimes *if.* A dependent noun clause can be either a subject or an object, no commas are necessary. A dependent adverb clause begins with an adverbial subordinator such as *when, while, because, although, if, so that,* etc (Oshima and Hogue, 1998:160-161).

Adverb clause consists of four types; adverb clause of time, adverb clause of cause and effect, adverb clause of contrast, and adverb clause of condition and adverb clauses are used to show relationship between ideas (Azar and Hagen, 2009:365). Adverb clause of time uses subordinating conjunction such as; *after, before, when, while, as, as soon as, since, until, by the time (that), once, as/so long as, whenever, every time (that), the first time (that), the last time (that), the next time (that).* Adverb clause of cause and effect uses *because, nowthat, since.* Adverb clause of contrast uses *even though, although, though, while.* Adverb clause of condition uses *if, unless, only if, whether or not, even if, in case.*

1.3 The Limitation of the Problem

Based on identification of the problem above, the researcher limited her study on findings the students' difficulties to use adverb clause of time using subordinating conjunction *after*, *before*, *when*, *while*, *as soon as*, *since*, *until*, *whenever*, *once*, and *every time (that)* and adverb clause of cause and effect using subordinating conjunction *because*, *nowthat*, and *since* in construct complex sentences.

1.4 The Formulation of the Problem

The researcher formulated the problem of this study as "what difficulties are found by the fourth year students at English Department of FKIP Bung Hatta University to construct complex sentences by using adverb clause? "

1.5 The Research Questions

The research questions were formulated as the following :

- What difficulties are found by the fourth year students of English Department of FKIP Bung Hatta University to construct complex sentences by using adverb clause of time ?
- 2. What difficulties are found by the fourth year students of English Department of FKIP Bung Hatta University to construct complex sentences by using adverb clause of cause and effect ?

1.6 The Purposes of the Research

The purpose of this study was to find out of difficulties made by the fourth year students to construct complex sentences by using adverb clause. Specifically, the purposes of this research were:

- a) To describe difficulties found by the fourth year students at English Department of FKIP Bung Hatta University to construct complex sentences by using adverb clause of time.
- b) To describe difficulties found by the fourth year students at English Department of FKIP Bung Hatta University to construct complex sentences by using adverb clause of cause and effect.

1.7 The Significance of the Research

The result of this study is expected to be very useful for lecturers and students. For lecturers, the information gives contribution and alternative considerations to them to achieve better improvement in teaching writing especially in constructing complex sentences by using adverb clause. Forstudents, it motivates the students at English Department of Bung Hatta University to improve their writing skill especially in constructing complex sentences by using adverb clause.

1.8 The Definition of the Key Terms

To avoid misunderstanding about the terms used in this research, the researcher gave the definition of the key terms as follows:

- a. Difficulty is something that a student cannot do correctly. In this research something refers to writing complex sentences.
- b. Constructing a sentence is to create a sentence by systematically arranging ideas or terms.
- c. A complex sentence is a sentence that contains one independent clause and one (or more) dependent clause(s).
- d. An adverbial clause is a dependent clause introduced by an adverbial subordinator (Oshima and Hogue, 1998:194).
