CHAPTER V

CONCLUSION AND SUGGESTION

This chapter includes the study's findings, combined with the following conclusion and suggestions. The conclusion represents a conclusion to the research questions stated by the writer in the first chapter, such as how Diane Sherman represents the symptoms of psychopathy in the movie *Run*, and how she shows the causes of psychopathy in the movie. In addition, this chapter includes suggestions for readers and future researchers.

5.1 Conclusion

The research findings show that the writer found out how Diane's symptoms and causes of psychopathy. For the symptoms, there are two categories. The first categories are the emotional interpersonal traits or feelings and relationships. These categories have six characteristics of psychopathy: glib and superficial, egocentric and grandiose, a lack of remorse or guilt, lack of empathy, deceitful and manipulative, and shallow emotions. The second category social deviance explains the lifestyle of psychopaths that also has six characteristics of psychopathy: impulsive, poor behavior controls, need for excitement, lack of responsibility, early behavior problems, and adult antisocial behavior.

The writer found a total of 19 data which are divided into the glib and superficial the writer found 2 data, 1 data of egocentric and grandiose, 2 data of a lack of remorse or guilt, 3 data of lack of empathy, 8 data of deceitful and manipulative, 2 data of impulsive, and 1 data of poor behavior controls. In the

first, almost all of the data was found in the form of Diane's efforts to make Chloe stay. Two symptoms dominate Diane's character. That is a lack of empathy, deceitfulness, and manipulation. The reason for Diane's lack of empathy, deceitfulness, and manipulative dominance is because of her character's fear of distance between herself and her daughter. When Diane knows that her daughter will leave her for college, she does everything to keep Chloe from leaving. Like throwing a letter of acceptance to make Chloe think she wasn't accepted to college, manipulating drugs to keep Chloe paralyzed, and doing everything she can to keep Chloe dependent on Diane. Despite everything she's done, Diane doesn't think of the negative impact of that because she lacks empathy. Diane always thinks that what she's doing is the right thing, so from there, she keeps doing it. The reasons why Diane gives Chloe dog medicine are to stay paralyzed, create another disease in Chloe, and also kill people to get Chloe back. These are some of the reasons why Diane's character is said to lack empathy. Diane wants to make sure Chloe stays by her side.

Meanwhile, for the causes of psychopathy in Diane's character, she showed several data. This data explains that there are 2 categories of causes of psychopathy which are nature and nurture. The writer found a total of 4 data on nurture characteristics. Poor living conditions have 1 data, physical abuse has 2 data, and 1 data on other traumatic incidents.

As a result, the theory explains that a psychopath needs something for their pleasure, and so does Diane's character. She defends the people she loves by

carrying out the most dominant symptoms in this study. She is deceitful and manipulative by deceiving many people around her and manipulating all of her daughter's illnesses just to satisfy her needs (to make Chloe stay). The reason why Diane doesn't want to be far from her daughter is because of past trauma. She is losing her daughter, which triggers Diane to become very obsessed after having Chloe. Another cause is physical abuse from her mother (Diane's mother), which also causes Diane's second dominant symptom, which is a lack of remorse or guilt. This makes Diane tend to feel that what she does is justified by her.

5.2 Suggestion

The writer hopes that readers will become more aware not just of strangers but also of people closest to them, based on the findings made in this study. While this thesis may not be perfect in terms of research, any mistakes can be corrected by other researchers. The writer hopes for this research to be helpful to anyone with an interest in studying similar subjects. In the end, the writer suggests that viewers with an interest in similar subjects do a comparison of the movie Run with different movies. The writer has studied psychopathy in Diane's character, and other researchers can research Chloe's character using other theories such as studying her psychological after receiving unpleasant treatment from her psychopathic mother.
