**Abstract**

This study aims to determine citizens' legal awareness of the ownership of Electronic Identity Cards (KTP-el) in Pasaman District, West Pasaman Regency. This type of research is a Mixed Method research that combines qualitative and quantitative models that are used at the same time in a study. Data collection techniques through observation, interviews, questionnaires and documentation. The results showed that (1) The public perception of the ownership of e-KTP in Pasaman District was very good, namely: 85% (2) Public Awareness of the Law of Owning E-KTP in Pasaman District was very good, namely: 86% (3) The driving factor for community awareness of ownership of e-KTP in Pasaman sub-district education level, community economic level, personal interests and age factors. (4) The government's efforts to increase public awareness of the law on ownership of e-KTPs are carried out by socializing the importance of e-KTPs, providing knowledge on how to administer e-KTPs, and holding pick-up activities for people who are constrained in making e-KTPs.

**Abstrak**

Penelitian ini bertujuan untuk mengetahui kesadaran hukum warga negara terhadap kepemilikan Kartu Tanda Penduduk Elektronik (KTP-el) di Kecamatan Pasaman Kabupaten Pasaman Barat. Jenis penelitian ini adalah *Mixed Method* penelitian yang menggabungkan antara model kualitatif dan kuantitatif yang dipergunakan dalam waktu bersamaan dalam suatu penelitian. Teknik pengumpulan data melalui observasi, wawancara, angket dan dokumentasi. Hasil penelitian menunjukkan bahwa (1) Persepsi masyarakat akan kepemilikan KTP-el di Kecamatan Pasaman Sangat Baik yaitu: 85%(2) Kesadaran Masyarakat Terhadap Hukum Akan Kepemilikan KTP-el di Kecamatan Pasaman Sangat Baik yaitu: 86%(3) Faktor pendorong kesadaran masyarakat terhadap kepemilikan KTP-el di Kecamatan Pasaman tingkat pendidikan, taraf ekonomi masyarakat, kepentingan pribadi dan faktor usia. (4)Upaya pemerintah dalam meningkatkan kesadaran masyarakat terhadap hukum kepemilikan KTP-el diadakannya sosialisasi akan pentingnya KTP-el, pemberian pengetahuan bagaimana cara pengurusan KTP-el, dan diadakannya kegiatan jemput bola bagi masyarakat yang terkendala dalam pembuatan KTP-el.
