ABSTRACT

Directives are a type of speech act used by speakers to convince someone else to take a specific action. This action conveys the speaker's goals or intentions. Commanding, ordering, requesting, prohibiting, and suggesting are types of directive speech acts. When a speaker gives a direction, they are trying to get the audience to act in a way that supports what they are saying. The study found that strategies are often used to achieve their communication goals. The writer uses a historical mystery movie as the source of data, the movie is called *Enola Holmes 2* which was released in 2022, and directed by Harry Bradbeer. There are two research questions analyze in this research. They are analyzing the categories of directive speech act in *Enola Holmes 2*, and analyzing the strategies of directive speech acts used in *Enola Holmes 2*. To analyze them, the writer uses theory from (Searle, 1979) about the type of directive speech act and (Cutting & Fordyce, 2020) about the speech act strategies. This research used qualitative research using the observation method. Based on the findings in this research, the writer found 70 directive speech acts. This research contributes to a better understanding of directive speech act types and the strategies used by the characters in the movie.

CHAPTER I

INTRODUCTION

Pragmatic itself explains how language is used in context and how people create and understand meaning through language. In other words, pragmatics provides information about people's intended meanings, their assumptions, goals and objectives, and types of actions. According to

Austin (1962), pragmatics are the fundamental units of communication in which utterances or discourse streams are understood as social acts that fulfill the purposes of society. On the other hand, discussing pragmatic analysis cannot be separated from conversation or an utterance that is related to the study of the speech act. As a result, speech acts play a crucial role in communication since they demonstrate how speakers employ language in daily social interactions. Strauss & Feiz (2014) state that speech acts are the key elements of communication, wherein utterances, also known as discourse spates, are perceived as social acts that fulfill social functions. There are five types of speech acts according to Searle (1969) which are representative, directive, commissive, expressive, and declarations.

The speaker's attempt to persuade the listener to take action is the main purpose of the Directive Speech Act. The speaker is always trying to affect the listener's behavior, although the extent of this influence can vary. For example, because the speaker used control over the listener, "I order you to leave" falls under the category of a directive. The participant can be the boss and the employee, thus, the speaker using directive speech act in the form of ordering. In general, almost every conversation involves directive speech acts.

Context is also important to know what is the meaning of someone's utterance, according to Levinson (1983) context involves only some of the components of the context of utterance, such as participants, identity, role, and location, assumptions that participants know or take for granted, the place of an utterance within a sequence of turns at conversing. The results of this study, which examined the speech acts in Enola

Holmes 2, have significance for the fields of communication and linguistics. They could be stated implicitly through indirect ways or direct speech acts. For the process to go more efficiently, speakers and participants must use the right strategies.

The writer is interested in choosing the title An Analysis of Speech Act in *Enola Holmes 2* Movie because speech acts are essential for daily communication, particularly when it comes to giving commands, requests, or suggestions. Directive speech acts are often used to develop the plot and show characters in movies like *Enola Holmes 2*. Analyzing these speech acts enables the writer to comprehend character interaction, power dynamics, and convey information.
