

# CHAPTER 1

## INTRODUCTION

### 1.1 Background of the Research

Linguistics concern with the nature of language and communication. It has to deal with the study of particular languages and the search for general properties common to all languages or large groups of languages. Meanwhile, language is a system and is communication tools which built from the customs that are closely related to the place are located. Searle (1976) there are five sorts of discourse acts: delegate, mandate, commissive, verbal, and assertions, as per the examination. The classes of discourse acts can be concentrated to recognize any expression in exchange made by characters in the film, yet the scientist is just intrigued by rule discourse acts. Searle claims that (1976), mandate discourse act is an endeavor by a speaker to get a listener to accomplish something. It implies that the listeners do what the speaker needs them to do. For instance taken from Searle (1976), "I request you to leave" implies that individuals might be unobtrusive 'endeavors' as when they propose others to accomplish something, or they might be exceptionally savage endeavors as when they demand others to do it. Meanwhile, Cutting (2002) expressed that there are an assortment of activities that can be performed through mandate discourse act, for example, mentioning, welcoming, denying, instructing, recommending. As illustration of mentioning taken from Cutting (2002), "Could you get me a fish and sweet corn one kindly?" can be seen that there is aim of somebody to make another person doing the activity. Likewise, it very well may be seen the guidelines of orders that the speaker should accept that it is feasible to do the activity that is endeavored by the speaker to listener.

The source of the data is "Toy Story 4" movie, this movie tells about a toy which having adventure and facing many problem, the movie was released on 2019, it is computer animated movie which the stars are the toys which is the next series of toy story franchise, the story centers after nine years all Andy's toy are given to a new owner where all of the toys separated and the story tells about "Forky" which is Bonnie's new toy which is thinking that he is not a toy and left Woody and the friends, the main theme of this movie is a toy named Forky, which

become Bonnie's favorite and it went missing, in the way finding Forky, Woody encounter many problem, such as talking doll Gabby-Gabby which want to take Woody voice box, the movie was premiered in Los Angeles and grossed \$1.073 billion worldwide.

Many directive speech acts are found in "Toy Story 4". This movie talks about the secret life of toys, which come alive whenever humans are not around. Set in a world where toys come alive, the world's first computer-animated movie focuses on the toys of a little boy named Andy Davis and centers on his favorite toy, a pull-string cowboy doll named Woody, worrying about being replaced by Andy's newest toy.
