ABSTRACT

Nurse is responsible in fulfilling the rights of patient in Solok Selatan Hospital – The regional hospital – as it has been regulated in Article 29 of Law No. 38 of 2014 about nursing that if the negligence occurs, the nurse has to be responsible directly to the patient. The research problems in this study, were (1) How was the nurse's responsibility toward the fulfillment of the patient's rights in the inpatient room of Solok Selatan hospital? 2) Have the patient's rights in medical services in the inpatient room of Solok Selatan hospital been already fulfilled? (3) What were the obstacles and efforts done in fulfilling the patient's rights in the inpatient room of Solok Selatan hospital? This research used a sociopolitical juridical approach. The data of this research was primary and secondary data. The primary data was acquired from questionnaires, interviews, and observations. The secondary data was acquired from document studies. This research used the qualitative research method. The results of this research were, (1) The fulfillment of patients' rights in the inpatient room of Solok Selatan hospital have not been implemented properly, (2) nurses were responsible administratively to the fulfillment of patient rights, and (3) There were three obstacles and efforts in fulfilling the patient's rights in the inpatient room of Solok Selatan hospital.

ABSTRAK

Perawat bertanggung jawab dalam memenuhi hak-hak pasien di RSUD Solok Selatan, sebagaimana telah diatur dalam Pasal 29 Undang-Undang Nomor 38 Tahun 2014 tentang Keperawatan sehingga jika terjadi suatu kesalahan atau kelalaian, maka perawat harus bertanggung jawab langsung kepada pasien. Rumusan masalah dalam penelitian ini, yaitu (1) Bagaimanakah tanggung jawab perawat terhadap pemenuhan hak-hak pasien di ruang rawat inap RSUD Solok Selatan? (2) Apakah hak-hak pasien dalam pelayanan medis di ruang rawat inap RSUD Solok Selatan sudah terpenuhi? (3) Apakah kendala dan upaya yang dilakukan dalam pemenuhan hak-hak pasien di ruang inap RSUD Solok Selatan? Penelitian ini menggunakan pendekatan yuridis sosiologis. Data yang digunakan merupakan data primer dan data sekunder. Data primer diperoleh dari kuesioner, wawancara, dan observasi. Data sekunder diperoleh dari studi dokumen. Data yang terkumpul dianalisis secara kualitatif. Hasil penelitian menunjukkan, (1) pemenuhan hak pasien di ruang inap RSUD Solok Selatan belum terlaksana dengan baik, (2) perawat bertanggung jawab secara administrasi terhadap pemenuhan hak pasien, dan (3) terdapat tiga kendala dan upaya dalam pemenuhan hak pasien di ruang inap RSUD Solok Selatan.
