#### Abstract

The objective of this study is to observe the effect of intellectual capital and financial performance of insurance firms in Kenya. This study was anchored human capita theory. The study targeted insurance firms in Kenya with employees as respondents. Explanatory research design with a sampling size of 372 staffs was used. Collection of data was done using closed ended questionnaire. Findings from Structural Equation Model indicated that human capital ( $\beta$  = .414,  $\rho$ <.05), social capital ( $\beta$  = .641,  $\rho$ <.05) and organization capital ( $\beta$  = .524,  $\rho$ <.05) had a positive and significant effect on firm innovation in insurance firms. The management of insurance firms should improve their intellectual assets in order to enhance their financial performance.


